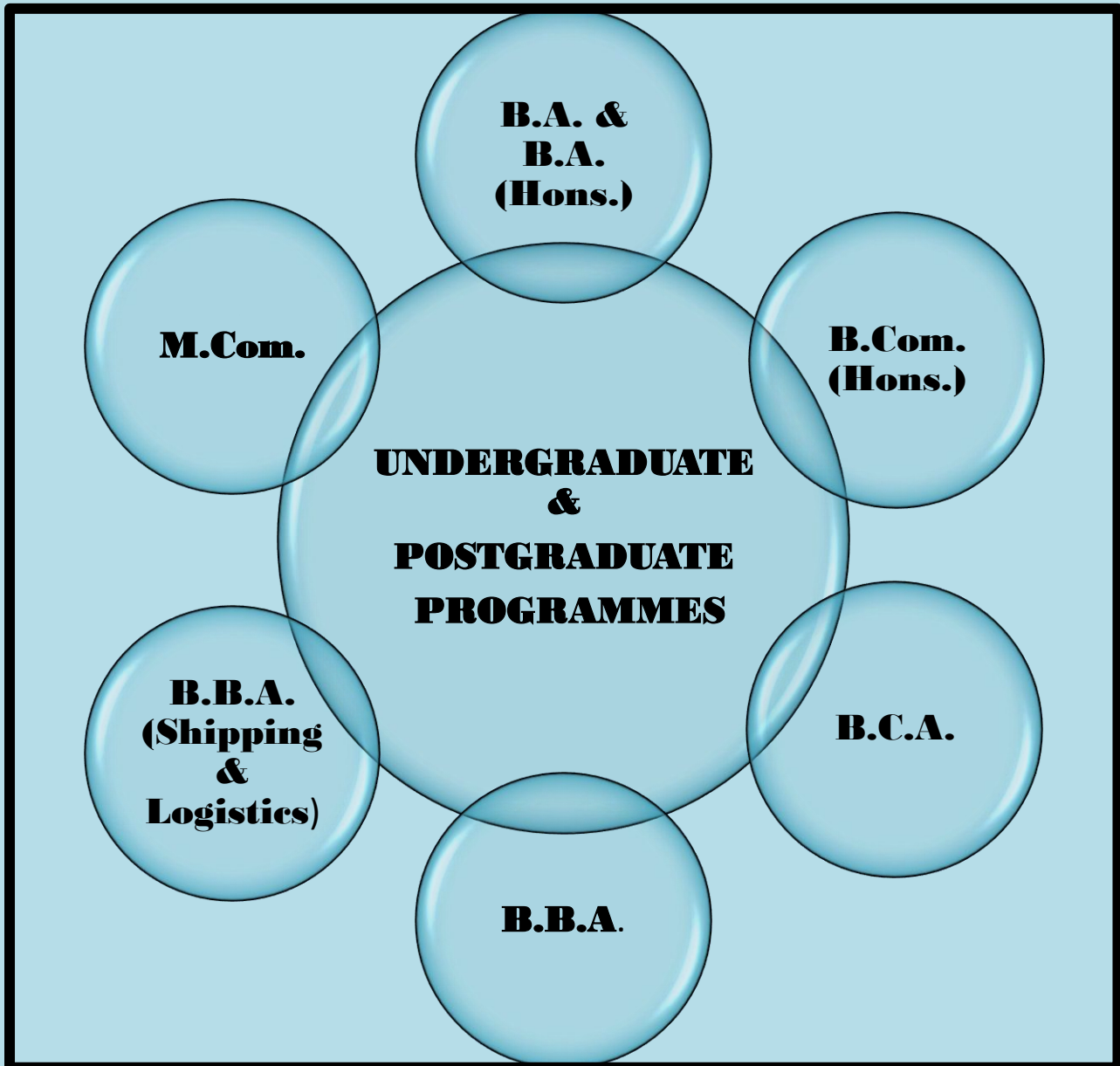

ADMISSION

I) PROCEDURE:*

(A) For B.C.A. Semester I & II

1. The link for the application form is available on the college website <https://www.mescollege.org/>
2. Gmail ID is mandatory to begin the admission process.
3. A passport size photo (not exceeding 1 MB) should be uploaded.
4. The admission form shall be uploaded along with the following documents (each document not exceeding 1 MB):
 - a. Scanned copy of original marksheet of HSSC/ Equivalent examination.
 - b. Original HSSC leaving certificate.
 - c. Eligibility Certificate (in original) issued by Goa University (for those students who have passed standard XII or any other equivalent examination through any other recognized Board other than Goa Board if applicable).
 - d. Scanned copy of original Aadhar card and first page of the bank pass book.
 - e. Scanned copy of original Caste Certificate.
 - f. Undertaking by the student.

- g. Undertaking by the parent.
- h. Undertaking for discipline and attendance.
- 5. Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
- 6. The student will receive an email on successful payment of fees confirming his/her admission.

(B) For B.C.A. Semester III, IV, V and VI

- 2. Gmail ID is mandatory to begin the admission process.
- 3. The PR number is mandatory to begin the admission process.
- 4. A passport size photo (not exceeding 1 MB) should be uploaded.
- 5. The admission form shall be uploaded along with the following documents(each document not exceeding 1 MB):

 - b. Scanned copy of original Aadhar card and first page of the bank pass book.
 - c. Scanned copy of original Caste Certificate.

 - f. Undertaking for discipline and attendance.
- 6. Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
- 7. The student will receive an email on successful payment of fees confirming his/ her admission.

II) ELIGIBILITY FOR ADMISSION (OC-67.2)

Eligibility for admission leading to the Degree of Bachelor of Computer Applications (BCA) shall be as follows:-

OC-67.2.1 Eligibility for Admission to Semester I and Semester II:

(A) To be eligible for admission to Semester-I of the Three Years course leading to the Degree of Bachelor of Computer Applications (BCA), the candidate should have passed:

(i) The Higher Secondary School Certificate (Std. XII) examination conducted by the Goa Board of Secondary and Higher Secondary Education in any stream, including the vocational stream in the subjects notified by the University from time to time.

OR

(ii) The Std XII or similar examination of another body equivalent to Goa Board of Secondary and Higher Secondary Education, Goa and recognized as such by Goa University.

(B) A candidate not covered under any of the above categories but desirous of seeking admission to the said course may apply to the College. However, the Registrar along with the Dean of the Faculty and the Chairperson of the Board of Studies shall decide the eligibility.

(C) A candidate admitted to Semester-I shall be deemed eligible for admission to Semester-II.

(D) A candidate migrating from another recognized University and desirous of direct admission to Semester-II may be considered for admission provided he/she has cleared/ passed Semester-I examination of that University with those subjects, under CBCS, for which admission is sought.

(E) A candidate shall be selected based on an entrance test. The entrance test shall assess the general aptitude, logical reasoning and analytical abilities and basic arithmetical skills of the candidate.

OC-67.2.2 Eligibility for admission to Semester-III and Semester-IV:

(A) A candidate who has requisite attendance for Semester-I and Semester-II and has attended minimum required ISAs of all the courses in Semesters I & II shall be eligible for admission to Semester-III.

(B) A candidate migrating from any other recognized University may be considered for admission to Semester III provided:

(i) He/she has passed in all courses of the Semester I and Semester II (First Year BCA) examination from that University.

(ii) He/she undertakes to successfully complete the required courses and credits prescribed for First Year BCA by this University, if he/she has not already done so in the previous University. Result of Semester IV examination shall be withheld if the candidate fails to fulfil this undertaking.

(C) A candidate admitted for Semester-III examination shall be deemed eligible for admission to Semester- IV.

(D) A candidate from another recognized University may be considered for direct admission to Semester IV provided he/she fulfils the conditions specified at (B) (i) and (ii) above and, in addition has passed/ cleared Semester III/ First Term examination of the Second Year BCA of that University. However, the result of Semester IV shall be withheld if the candidate does not fulfill these conditions.

OC-67.2.3 Eligibility for admission to Semester-V:

(A) A candidate who has been declared Passed in Semester I to Semester IV examinations shall be eligible for admission to Semester V.

(B) A candidate admitted for Semester-V shall be deemed eligible for admission to Semester-VI.

(C) A candidate migrating from any other recognized University may be considered for

admission to Semester-V of the BCA Course provided:

(i) He/she has been declared Passed in Semester I to Semester IV examinations from that University, and

(ii) He/she had taken at the Second Year the required courses and credits under the scheme of this University. A candidate fulfilling these conditions shall be eligible for admission to Semester-V only.

OC-67.2.4 Eligibility for admission to Semester-VI:

(A) A candidate already admitted for Semester-V shall be deemed eligible for admission to Semester-VI.

(B) Direct admission to Semester-VI shall not be permitted.

Please note: All provisions of the present Special Ordinance OS-1 (Special ordinance relating to the conduct of Academic Programmes during COVID -19 pandemic) of Goa University shall temporarily supersede the relevant provisions of other Ordinances that govern the Academic Programmes of the University, Academic Terms and Conduct of Examinations. OC-67.2.5 Class strength:

Maximum number of students in a class/ division shall not exceed forty. For practical's the batch size shall be up to a maximum of 20 per batch.

- (a) If a student chooses to withdraw from the programme of study in which he/she is enrolled, the following four-tier system shall be followed for the refund of fees remitted by him/her.

Sr. No.	Point of time when notice of withdrawal of admission is served to the College/University	% of refund Aggregate fees*
1.	15 days before the formally notified last date of admission.	100%
2.	Not more than 15 days after the formally notified last date of admission.	80%
3.	More than 15 days but less than 30 days after formally notified last date of admission.	50%
4.	More than 30 days after formally notified last date of admission.	00%

(Inclusive of tuition fees and non-tuition fees but exclusive of Caution Deposit and Security Deposit)

- (b) In case of (1) in the table above, 10% of the aggregate fees shall be deducted as processing charges from the refundable amount.
- (c) Fees shall be refunded to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.
- (d) The fees of students who have already been admitted to a programme of the University and have paid the fees and are subsequently admitted to another programme shall have to pay the fees for the final admission and claim the refund of fees paid earlier, in which case no administrative charges shall be deducted from fees paid earlier by the student. However, if the fees payable for both the programmes are the same, the fees paid earlier shall be transferred to the final programme where admission is sought.
- (e) All the other cases of refund of the fees will be decided on case to case basis on its merit.

PROGRAMME STRUCTURE FOR BACHELOR OF COMPUTER APPLICATIONS



B.C.A. UNDER CBCS

The Programme shall be based on a system of time-integrated Units called Credits, under the CBCS. The Programme shall comprise Courses such as Core, Elective and Ability Enhancement Courses. A Credit shall consist of 15 clock hours of theory of 1 hour duration each or 15 practical classes of 2 hours duration each, per semester or its equivalent; Field work and such other as recommended by the Board of Studies (BoS) shall be considered under practical category for calculating credits and workload. A student shall be eligible for the award of BCA Degree on successful completion of minimum of 132 Credits, to be completed over a minimum of six Semesters.

OC-67.4: COURSE STRUCTURE:

1. Each Course can carry different weightage in terms of number of Credits. Each Course should define learning objectives and outcome. A course may be designed so as to comprise any or combination of lectures/ tutorials/ laboratory work/ field work/ outreach activities/ project work/ vocational training/ viva/ seminars/ term papers/ assignments/ presentations/ self-study/ such other.

2. **Core Course (CC):** A course, which should compulsorily be studied by a candidate as a core requirement is termed as a Core Course. Each Core Course is of 4 credits or 2 credits and may consist of theory and practical component or only theory component or only practical component. If the course has a theory and practical component, the theory component will be of 3 credits theory and 1 credit practical for 4 credit course. If the course has only practical component, this component will be of 2 credits. The candidates are required to compulsorily pass all the Core Courses of the Programme.

3. **Elective Course:** An Elective Course can be chosen from a pool of Courses, which may be specific or specialized or advanced or supportive to the discipline/ subject of study or which provides an extended scope or which enables an exposure to some other 555 discipline/ subject/ domain or which nurtures the candidate's proficiency/ skill. An Elective Course may be Discipline Specific Elective Course or Generic Elective Course.

3.1 **Discipline Specific Elective (DSE) Course:** Discipline Specific Elective (DSE) Course shall be offered in the main discipline/subject of study. Each DSE shall be of 4 credits and may consist of theory and practical component or only theory component. If the course has a theory and practical component, the theory component will be of 3 credits theory and 1 credit practical or as prescribed by BoS and approved by the Academic Council. Any number of DSE's as approved by BoS and AC, can be offered depending upon the specialization available in the college.

3.2 **Project:** A compulsory Project work of total 4 credits shall be offered in lieu of a DSE Course in Semester VI and shall be designed to acquire special/ advanced knowledge; it shall

be specialised course involving application of knowledge in solving / analysing / exploring a real life situation / difficult problem. Students shall undertake such a project under the guidance of a teacher / faculty member. The topic for the Project Work shall be given in Semester V. Students shall be required to carry out work for the Project during Semesters V & VI. The assessment of the Project will be carried at the end of Semester VI.

3.3 Generic Elective Course: A Generic Elective(GE) course shall be of 4 Credits, and may be chosen from an unrelated discipline/subject, with an intention to seek exposure. A Core Course offered in a discipline/subject may be treated as GE Course for another discipline/subject and vice versa. If the course has a practical component, the theory component will be of 3 credits theory and 1 credit practical or as prescribed by BoS and approved by the Academic Council.

4. Ability Enhancement Courses (AEC): The Ability Enhancement (AE) Courses may be of two kinds:

4.1 Ability Enhancement Compulsory Courses (AECC): AECC are based upon the content that leads to knowledge enhancement. Courses on Environmental Studies, Communication Presentation Skills and Technical Writing Skills are mandatory. Communication Presentation Skills and Technical Writing Skills will have 4 credits each and course on Environmental Studies will have two separate courses of 2 credits each.

4.2 Skill Enhancement Courses (SEC): SEC courses are value-based and/or skill-based and are aimed at providing hands-on-training, competencies and skills. These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based knowledge. Each course will be of two credits or as prescribed by BoS and approved by the Academic Council.

FINANCIAL ASSISTANCE (FREESHIPS /SCHOLARSHIPS/ AWARDS)

(A) Government Schemes

- I. Post Matric Scholarship for students belonging to minority community.
- II. Freeships to the students belonging to the Scheduled Caste, Scheduled Tribe and Other Backward Classes (In case of OBC, the family income should not exceed more than Rs 6,00,000 p.a).
- III. Post Matric, Gagan Bharari merit based scholarship to ST students.
- IV. Sant Sohrobanath Ambiyé Dnyanvrudhhi Shishyavrutti (Bursary Scheme).

(B) College Schemes:

Student Aid Fund

Student Aid Fund is created to give financial assistance to the deserving candidates from humble backgrounds upto a maximum of Rs 3,000/- per year to meet partly or fully their tuition fees or to purchase books or similar other expenses. To be eligible for the assistance, the annual income of the parents should not exceed Rs 1,50,000/-. The beneficiary should not be in receipt of any other scholarship / assistance except the merit scholarship.

Note:

As per the financial rules of the Government. a student who is awarded more than one prize /scholarship/freeship, can avail of only one prize /scholarship/freeship of highest value. Prizes/scholarship/freeship awarded to the students are liable to be withdrawn on grounds of indiscipline, misconduct, misbehaviour, irregularity in attendance at lectures/tutorials, test/examination etc. on the part of the student.

CODE OF CONDUCT

1. **In every matter relating to the college, the decision of the Principal shall be final and binding upon every student.**
2. Attendance for lectures and practicals is compulsory. The minimum requirement for attendance is 75% aggregate and 50% in each course of the respective semester as per Ordinance OA-17 of the Goa University.
3. Students have to abide by all the rules and regulations framed from time to time by the Principal or by the persons authorized by him/her.
4. Insubordination to any teacher or to any college authorities, use of indecent language, misbehaviour or misconduct is liable for disciplinary action as per the rules.
5. Ragging is strictly banned in the college. Any student found indulging in ragging will be severely dealt with, as per UGC Regulations.
6. Wearing of Identity card is mandatory for students in the college premises. Loss of an identity card must be reported to the College Office immediately. A duplicate card will be issued on payment of the prescribed fee.
7. Students are expected to strictly adhere to lecture timings. The lectures are conducted from 9.00 a.m. to 2.00 p.m. The college office timings are from 10.00 a.m. to 5.00 p.m.
8. Damage to college property/reputation in any form is punishable. If found guilty, responsible individual(s) would be liable to pay for the damages in addition to repercussion faced.
9. Students are required to adhere to the Examination Ordinance of Goa University. Please refer to the Goa University Ordinance OC-67 available at: https://www.unigoa.ac.in/uploads/config_docs/20200309.111858~Ordinances_Part_C_6_Mar_2020.pdf

10. Students shall require prior permission from the Principal for organizing/ involvement in any activity (monetary/non-monetary in nature) in the college premises.
11. Consumption and possession of tobacco or alcohol or any form of intoxicant in the college campus is prohibited and punishable.
12. A student applying for Medical Leave must produce a medical certificate from a registered medical practitioner within seven days of resuming classes.
13. Accompanying of unauthorized personnel in college campus is prohibited and punishable.
14. Visitors are required to acquire a visitors' pass while entering the college premises.
15. Students are expected to clear/pay their dues (sports, library, other damages etc.) before collecting their results. On failing to do so, the college reserves the right to withhold the Examination result.
16. Parents/Guardians are advised to contact the College authorities from time to time in order to appraise themselves of the progress of their wards and their attendance.

17. Use of unfair means during examination (ISA/SEE) is strictly prohibited. A student, if found guilty, shall be liable for punishment as per the rules prescribed by Goa University.
18. Unauthorized use of mobile phones in class is strictly prohibited. Any student violating this rule shall face disciplinary action.
19. Due to paucity of parking space, the College does not guarantee parking space for four/two wheelers for students and would not be responsible for any damage/theft caused to vehicles.
20. Security personnel or any staff appointed by the Principal will have full authority to check and verify the identity cards of every student and have right to interrogate any student, in view of security concerns of the college.
21. Maintenance of college discipline, adherence to its rules and code of conduct and obedience to the instruction issued from time to time by Principal or other college authorities will be mandatory and binding on each student. Appropriate disciplinary action will be taken which includes suspension/expulsion and rustication as per the directives of Goa University and College Discipline Committee.

- **Internal Complaints Committee (ICC)**

Objectives, Roles and Responsibilities of College Internal Complaints Committee

1. Prevent discrimination and sexual harassment, by promoting gender amity among students and employees;
2. Deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment; The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 came into being after it was passed in the Parliament of India.

It should be noted that according to the Supreme Court guideline Sexual harassment can be defined as “unwelcome” sexually determined behaviour (whether directly or by implication) as:

1. Physical contact and advances;
2. Demand or request for sexual favours;
3. Sexually coloured remarks;
4. Showing pornography; and
5. Other unwelcome physical, verbal or non-verbal conduct of a sexual nature. (Vishaka judgment by Supreme Court)

The following is also sexual harassment and is covered by the Committee:

- Eve-teasing
- Unsavory remarks,
- Jokes causing or likely to cause awkwardness or embarrassment,
- Innuendos and taunts,

- Gender based insults or sexist remarks,
- Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like,
- Touching or brushing against any part of the body and the like,
- Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings,
- Forcible physical touch or molestation and
- Physical confinement against one's will and any other act likely to violate one's privacy.

The Committee shall meet as often as may be needed and appropriate.

EXTRA-CURRICULAR ACTIVITIES

Students are advised to take part in various extra-curricular activities.

1. Department of Physical Education and Sports

The Department of Physical Education and Sports of M.E.S College aims at all round development of each and every student through the participation in various games and sports. The Department organizes various activities and intra-murals such as Inter-class Tournaments, Athletic Meet, which provides an opportunity to the students to showcase their talents. 2. National Service Scheme (NSS)

National Service Scheme (NSS) is a voluntary community service scheme for the youth studying in the higher educational institutions. The aim of NSS is to bring out a positive social and political change in the lives of youth by developing various dimensions of their personality. NSS volunteers are made socially, emotionally, politically and environmentally sensitive towards the process of national building. The NSS Unit organizes a 7 day residential 'Annual Special Camp' in a rural area.

All students are encouraged to enrol for NSS. A student joining NSS shall complete 240 hours of NSS regular activity over a period of four semesters completing 60 hours of regular N.S.S activity per semester and one 7 day residential 'NSS Annual Special Camp'.

3. National Cadet Corps (NCC)

There are 3 divisions/ wings of NCC in M.E.S. College viz, **Army Boys Wing, Army Girls Wing and Naval Wing.** Army Boys Wing and Naval Wing are available for boys (SD) and girls (SW). NCC is open to all regular students of the college on a voluntary basis. Total training period is three years. The cadets have to appear for 'B' certificate exam after completion of two years and 'C' certificate exams after three years of training. NCC provides a suitable environment to motivate the youth to take up a career in the armed forces. Free SSB guidance is provided to interested cadets. NCC provides uniform, washing allowance, refreshments during the parade, T.A., D.A.



On successful completion of the above activities, the NSS volunteer shall become eligible to receive a 240 hours completion certificate, issued by Directorate of sports and Youth Affairs, Campal, Panaji, Goa.

4. Activities organized by Various Associations/Cells and Departmental Associations /Clubs

FACILITIES

The College offers the following facilities on the campus:

Library: The College has a fully automated library with a collection of approximately 34,103 books and 42 journals and periodicals. The library is equipped with NEW GENLIB software 3.1.4 version. The library is also a member of the N-List program of INFLIBNET. The College has registered for the National Digital Library provided by the MHRD. The library facility is extended to the public. Under the book bank facility, books are given to the meritorious and economically backward students and to students who have enrolled for remedial coaching classes.

Laboratories: The college has well-equipped laboratories, namely, IT Lab, Psychology Lab and Economics Lab.

Sports: The sports facilities include gymnasium, gymkhana/ multi-purpose hall for indoor games, football ground, volleyball court and two basketball courts.



Stationery Shop: The college has a stationery shop which also provides photocopying and printing facilities.

Cafeteria: We now have our very own open-air cafeteria on campus 'MESCAFE' which provides a student friendly ambience.

Canteen: The College has a spacious canteen offering snacks and lunch.



Counselling: The services of two full-time counselors are available for the benefit of students. The counselors are available on all days of the week from 8.00 a.m. to 2.30 p.m.

Health Centre: The College has a Health Centre which is equipped with a bed, first aid box and wheel chair facilities. A private physician visits on a weekly basis.

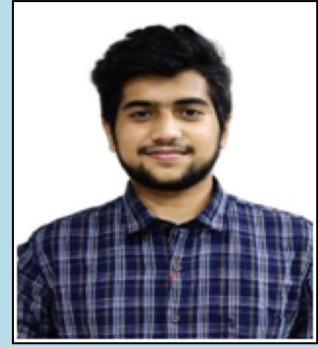
