TWO DAYS WORKSHOP ON TOPIC “FILING OF INCOME TAX RETURNS”

The basic objective of the workshop was to give practical training to the students in Filing of Income Tax Returns.

The Resource Person for the workshop was Ms. Komal Bandekar, Taxation Maanger at P.P Mahatme and Co and Full time Tax Consultant . Ms. Komal Bandekar is the ex-student alumni of MES College graduated in commerce in the year 2011. On this day the workshop commenced at 1.45 pm with the welcome address and introduction of the resource person by the Head Department of Commerce and M.Com Programme Mentor Dr. Champa R Parab, where Principal Dr. Manasvi M Kamat in her opening remark highlighted the significance of learning how to file income tax returns.
