

50 Years of the College

The journey of Murgaoon Education Society began on 23rd August 1971, under the Chairmanship of late Shri Vasanttrao Joshi and several enlightened persons, in the Joshi building at F. L. Gomes Road, Vasco-da-Gama. It was established to serve the youth of Goa, particularly the youth from the Port Town, with affordable and high-quality education.

The College was shifted to its current campus in Zuarinagar, in June 1985. Since then, the barren Zuarinagar plateau has undergone significant transformation. With the initiation of measures like afforestation, rainwater harvesting, vermicompost and the recent installation of solar panels, the College provides an eco-friendly environment to our faculty, students and visitors. The infrastructure of the College grew at a steady pace over the years.

In order to provide quality education to the students of the Port Town, a Higher Secondary School with 4 streams: Arts, Commerce, Science, Vocational and an Institute of Management Studies were set up subsequently. The College section initially began with BA and BCOM programs and expanded to a Computer Applications Course, as well as the Course in Management, the BCA and BBA (General) programs were introduced. An industry specific Diploma course in Shipping Management was instituted which has now been replaced with a Graduate degree (BBA) in Shipping & Logistics. A Postgraduate Degree, MCOM was also introduced in 2016.

Over the last 50 years, the College and Higher Secondary Section have been the alma mater for many young men and women from humble economic and social backgrounds. The alumni have indeed risen to great heights and excelled in fields, ranging from education to banking, business to public administration, rendering their service to society and Goa.

The College has had a smooth transition from the traditional 'chalk and blackboard' method, to the OHP method and more recently, to Audio-visual teaching and the use of the LCD Projector. The college has further advanced in terms of technological progress, with the launching of Smartboards in some classes. The College has also gone a step ahead in extending the use of the campus to the community at large. It has allowed people in the vicinity to utilize the infrastructure and facilities, such as, the Basketball court, library, etc, while also being a venue for professional examinations.

The flag of MES continues to fly high, with achievements by the Faculty in several areas of research, expertise and Co-curricular activities. Our students have excelled in terms of NSS, NCC Navy and Army, as well as in Sports.

The College has celebrated its Golden Jubilee year and has been renamed as '*MES Vasant Joshi College of Arts & Commerce – Zuarinagar*', to honour the philanthropic work of our Founder Late Shri. Vasant Joshi.

This year with the implementation of the National Education Policy (NEP 2020), the future of education seems more innovative and flexible for the students to choose their courses.

The road ahead for the next 50 years proves to be very promising with the help of the Management, Faculty and students.

Murgaon Education Society's Vasant Joshi College of Arts & Commerce is one of the premier institutions of higher education in the state of Goa. The college was founded by the great visionary and philanthropist Late Shri. Vasant Subrai Joshi to cater to the need of educational upliftment of youth in Vasco- da- Gama in particular and the state of Goa in general. The College premises was shifted to the present campus in 1985. Over the years, the campus has been transformed from barren, rocky and unyielding land into a lush green, fertile paradise where students aspire to pursue their higher studies.

It was one of the first composite Arts and Commerce colleges in the state of Goa to be affiliated to the University of Mumbai and then to Goa University. The college is currently offering five undergraduate programmes in Arts, Commerce, B.B.A., B.C.A., B.B.A. (Shipping and Logistics) and one postgraduate programme, namely M.Com. To cater to the requirements of the Shipping and Logistics industry, M.E.S. Vasant Joshi College introduced B.Com. (Shipping Management) which was initially funded by UGC for five years and is currently running as self-financed programme as Bachelor of Business Administration (Shipping & Logistics).



The B.B.A. (Shipping and Logistics) programme is the first undergraduate programme in India which addresses the commercial and managerial side of the shipping industry. At present, the college has approximately 1534 students and 69 full-time teaching faculty.



The college encourages high academic standards. We instil in our students a passion for learning and acquiring knowledge that they will require to make a positive contribution to the society. The college imparts learner-centric education which aims at the holistic development of the students by developing creative and critical thinking, nurturing innovations and excellence, developing professional skills etc.

At M.E.S. Vasant Joshi College, we believe in holistic education that comprises deep as well as broad academic and co-curricular exposure. Hence, academics is always complemented with co-curricular and extra-curricular activities in the campus.

In recognition of the high standards of education and the all-round excellence attained by it, the College was selected by the UGC for introducing vocational courses at the B.A. and B.Com. Degree level, and by the Ford Foundation USA for implementing its Campus Diversity Initiative Programme. The college was accredited by NAAC with a B + - CGPA of 2.68 Grade (Fourth Cycle) in the year 2021.

The College celebrated its Golden jubilee this year and it was renamed M.E.S. Vasant Joshi College of Arts & Commerce, to pay tribute to our founder Late Shri. Vasant Joshi (Anna).

Two Years Full Time Self-Financed Programme Affiliated to Goa University

The **M.Com programme** offered by the college is a two-year full time degree programme affiliated to Goa University. At present the M.Com programme offers specialisation in Accounting and Finance only. The M.Com programme is based on the existing course structure for the same programme offered by Goa Business School of Goa University.

ADMISSION

I) PROCEDURE:*

(A) For M. Com. Semester I & II

1. Challan to be collected from college administrative section (Accountant), payment to be made, scan copy of payment made to be attached to challan, fill Google form submit online and print to be submitted to accountant.
2. The application form shall be filled online at www.mescollege.org
3. Students should have a Gmail account.
4. A passport size photo (not exceeding 1 MB) should be uploaded.
5. The admission form shall be uploaded along with the following documents (each document not exceeding 1 MB):
 - a) Scanned copy of original mark sheet of B.Com examination and two self-attested photocopies of the same.
 - b) Eligibility Certificate (in original) issued by Goa University (for those students who have passed B.Com examination through any other recognized University other than Goa University if applicable)
 - c) Scanned copy of original Aadhar card and first page of the bank pass book
 - d) Scanned copy of original caste certificate
 - e) Undertaking by the student
 - f) Undertaking by the parent
 - g) Undertaking for discipline attendance
6. Identity Card Slip
7. Six copies of recent passport size photographs
8. Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
9. The student will receive an email on successful payment of fees confirming his/her admission.

B) For M. Com. Semester III & IV

- 1) Challan to be collected from college administrative section (Accountant), payment to be made, scan copy of payment made to be attached to challan, fill Google form submit online and print to be submitted to accountant.
- 2) The application form shall be filled online at www.mescollege.org
- 3) Students should have a Gmail account.
- 4) A passport size photo (not exceeding 1 MB) should be uploaded.
- 5) The admission form shall be uploaded along with the following documents (each document not exceeding 1 MB):
 - a) Scanned copy of original mark sheet of previous semester examination (I and II)
 - b) Scanned copy of original Aadhar card and first page of the bank pass book
 - c) Scanned copy of original caste certificate
 - d) Undertaking by the student
 - e) Undertaking by the parent
 - f) Undertaking for discipline and attendance

- g) Students from other colleges (not affiliated to Goa University) should submit provisional Eligibility Certificate issued by Goa University and Migration Certificate and Transfer Certificate from their respective Universities.
- 6) Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
- 7) The student will receive an email on successful payment of fees confirming his/her admission.

D) Eligibility for Admission (OC-45.2 of GU Ordinance)

2.1 The eligibility criteria for admission to the M.Com Programme are as under:

- 1. Candidates must pass the Bachelor of Commerce Degree examination of Goa University or any other recognized university with a minimum of 45% marks.
- 2. Candidates must pass the Entrance Examination conducted by Goa University.
- 3. Admission is based on the ranking at Entrance Examination conducted by Goa University
- 4. A candidate admitted for Semester-I shall be deemed eligible for admission for Semester II.

Please note: All provisions of the present Special Ordinance OS-1 (Special ordinance relating to the conduct of Academic Programmes during COVID -19 pandemic) of Goa University shall temporarily supersede the relevant provisions of other Ordinances that govern the Academic Programmes of the University, Academic Terms and Conduct of Examinations. SEMESTER - I

COM-500 Advanced Financial Management

This course is designed to provide fundamental knowledge about the finances and management of the company linked to long-term and short-term decisions. The course provides tools to manage and run a company or organization, understand its competitive and institutional positioning, identify its strengths and weaknesses, and evaluate the situation and the foreseeable evolution of the company based on the relevant records of information.

COM-501 Capital Markets and Stock Exchange Operations

This course focuses on the Overview of Indian capital markets that incorporate both Primary and Secondary markets. Further, the students will be exposed to the trading and settlement procedures in the Indian capital markets. Students shall be equipped with knowledge of stock market indices and the risk management and surveillance system in Indian capital markets.

COM-502 Entrepreneurship and Venture Capital

In the globalized world, the need for entrepreneurial talents is gaining prominence as it provides employment opportunities for all other growth agents for economic transformation. Those with the qualities of becoming entrepreneurs must know the different ways of financing new ideas. One such financing avenue is venture capital and private equity. The intricacies of how venture capitalists can obtain funding require a complete understanding of how venture capital and private equity function. Students may be able to become one of the growth agents in transforming the economy after successful completion of the course.

COM-503 Organizational Behaviour

This course covers all essential topics that will enhance students' knowledge of "Organizational Behaviour." It covers topics related to the organization, i.e., understanding of individual behavior, Various types of Groups operating in an organization, Power and Organizational Politics, Conflict Management Causes, Effects and Management of conflict at different levels of conflict and change management, Stress Management and Counseling.

COM-521 Advanced Corporate Accounting

This course will cover all the aspects companies normally follow during their life. This course refines your knowledge of corporate accounting concepts and practices. It covers the preparation of companies' financial statements following the Companies Act 2013, the procedure for amalgamation and liquidation of companies, and the preparation of holding company accounts.

COM-522 Financial Services Operations

This "Financial Services" course covers all essential topics that will enhance students' knowledge of Financial Services. It covers topics related to an Overview of Fund based and Fee-based services, understanding practices, and research work done by the Credit Rating Agency with rating process and methodology. Structuring mechanism of Securitization with Legal Aspects. The efficient depository is critical to the efficient functioning of the Capital Market. This course provides deep insight into the Depository's functioning and outlines the various Operational issues

SEMESTER - II

COM-504 Marketing and Consumer Behaviour

This course is designed to motivate the students to understand (1) the basics of marketing, recent developments in marketing, marketing environment, market segmentation, targeting, and positioning, and (2) understand the intricacies of consumer behavior in marketing and various theories developed in understanding how and in what way consumers behave, and (3) consumer behavior w.r.t who the consumers are, what makes them behave differently, are the consumers happy or not, and what consumers do to express their experiences.

COM-505 Management of Mutual Funds

This course covers all essential topics that will enhance students' knowledge in the Mutual Fund industry. It covers the basics of Mutual Funds, their role and structure, different kinds of Mutual Fund Schemes, and their features. Further, it also covers Offer Document along with investment plans. This course discusses the various services offered to present and prospective investors. It will benefit all who want to understand the Indian Mutual Fund industry better.

COM-506 Security Analysis & Portfolio Management

Security analysis is about valuing companies' assets, debt, warrants, and equity from the perspective of outside investors using publicly available information. Also, building a successful investment plan requires a fundamental change in how we think about investing. This course aims to provide analytical skills for better analysis of securities and management of portfolios. The course outlines the topics such as Analysis of Risk & Return, Valuation, and Analysis of Equity & Debt, Portfolio Analysis & Selection, and Portfolio Performance Evaluation & Revision, which are essential components for investment and trading in financial markets.

COM-507 Financial Derivatives

(1) Analyzing Various Derivative Contract Specifications from Exchanges (2) Mark to Market Margin Calculation on Real-time data from Exchanges (3) Understanding the trading and settlement process and other documentary requirements at Brokers' office to pen the trading account (4) Calculating the futures and options price with the cost of carrying, binomial and BS Models on real-time data from Exchange & analyzing them with current market price (5) Forming of different futures and options trading strategies with the real-time data from Exchange.

COM-525 Direct Taxes

This course makes the student aware of various direct tax laws and procedures required in planning the individual tax assessment. This course would enable students to build their careers in tax planning. This course enables the student to understand and compute the income from salaries, house property, business income, capital gains, and income from other sources. Further, it provides comprehensive knowledge on deductions from total gross income, tax rates available for the respective assessment year, tax deducted at source, filing of returns, and advance tax payment. While learning this course, the student must follow the current financial year as their assessment year.

COM-526 Cost and Management Accounting

Cost and Management Accounting is significant and valuable for optimum utilization of existing resources. It is an indispensable discipline for Corporate Management, as the information collected and presented to Management based on Cost and Management Accounting techniques helps solve specific problems and guides them in decision making. This course is designed to motivate the students to understand (1) Introduction to Cost and Management Accounting and Marginal Costing (2) Standard Costing and Budgetary Control (3) Preparation and Interpretation of Financial Statements (4) Preparation of Fund Flow and Cash Flow Statement

SEMESTER - III

COM-600 Research Methodology

This course is designed to give an overview of different approaches to research design (focusing on quantitative, qualitative and mixed) which will motivate the students to identify research gap, identification and collection of relevant data (uni-Variate, bi-Variate, and multi-Variate data sets) and finally analysis of data using various statistical techniques starting from reliability/normality testing, organising, describing, relationship and prediction, and testing the significance. Students will be also familiarized with intellectual honesty and ethics while preparing a research report.

COM-601 Basic Econometrics

Basic econometrics course is designed to provide knowledge of fundamental concepts in econometrics and familiarise learners with basic econometric tools. The course details on regression methodology of modelling including its forms, assumptions and diagnostics. It further includes topics in econometric analysis of cross-section data with particular focus on dummy variables and basic time series econometric models for forecasting.

COM-602 Qualitative Research

Qualitative Research is gaining prominence, and knowing in-depth knowledge of the theoretical and methodological approaches to qualitative research enables the students to explore and apply these methodologies in practical situations related to their field of study. The

course helps to examine the value of qualitative research design in understanding social and behavioural phenomena, with a primary focus on narrative approaches to qualitative inquiry across the research process, from theory/guiding frameworks to method (data collection) to analyzing data to presenting/writing translatable results. The course enables the students to understand the importance of active listening during in-depth interview stage while carrying out qualitative research, which helps them to gather relevant and required data effectively on time.

COM-621 Corporate Valuation

This course will provide a good understanding about various aspects of Corporate Valuation. The course outlines the topics such as Overview of Corporate Valuation, Enterprise Discounted Cash Flow valuation, Relative Valuation & Non-DCF Approaches to Valuation, and Value Enhancement which are vital elements of corporate valuation.

COM-622 Corporate Mergers and Acquisitions

This course covers all essential topics that will enhance the knowledge of students in “Corporate Mergers and Acquisitions”. It covers topics related to the basics of Various Forms of Corporate Restructuring, Restructuring Underlying Issues - Growing need for Corporate Restructuring in Recent times in India, Theories of Mergers, Types of Mergers & Mergers and Acquisitions Process and Takeover Defenses. It will be immensely useful to all those who want to have a better understanding of Corporate Mergers and Acquisitions.

COM-623 Indirect Taxes

This course is designed to develop the students with the various concepts of goods and service tax act law and procedures. The students learning this course shall understand about the persons liable to pay GST, valuation under GST, reverse charge, input tax credit, exemption from GST, composition scheme as well as the procedures of Customs duty.

COM-624 Financial Risk Management

The course will provide an understanding of the concept of risk and the application of risk management techniques to identify, evaluate and mitigate the various types of risk. Students will also be able to understand operational risk, credit risk and be equipped with the knowledge of managing these risks. Further students will also be able to understand risk management and surveillance system in Indian stock markets.

COM-625 Treasury and Forex Management

This course aims at enabling the students to acquire skills for treasury management and understand the intellectual foundations of global financial markets, instruments and products, as also their use in managing financial risks.

COM-626 Cost Management and Control

This course is designed to provide knowledge about the basics of Cost management. This course also helps the students in understanding the various techniques and performance evaluation methods used for controlling cost. It will also help the students to understand how to take decision to control the various costs by using LPP model, transportation and assignment problems.

SEMESTER - IV

COM-603 Advanced Econometrics

Advanced econometrics develops on the basics of financial econometrics course and extends to the study of advanced econometric models with applications in cross-section, time series and panel data. Special advanced regression models designed for limited dependent variable, advanced multivariate time series models with vector autoregression specification, models for examining long-run relationship between variables of interest are covered in this course. Similarly, advanced volatility models and panel data econometrics with detailed procedures for identifying right panel data models are also included in this course.

COM-604 Business Analytics

The course introduces learners to the concept of business analytics and reliable ways to collect, analyse, and visualize data—and utilize data in making business decisions. The course will cover data modelling and predictive analytics at a high-level. The major categories of business analytics are covered in significant detail. This includes descriptive and predictive analytical techniques.

COM-651 Dissertation

This course helps the students in acquiring the required knowledge about how to carry out a successful research. This course helps students in applying the research knowledge gained during previous semesters in to practical situations where in they will be able to develop the skill of carrying out extensive literature review relevant to the research problem, developing research gap, related research questions to be solved, relevant / appropriate objectives, related hypothesis and also the tools and techniques to be applied for data analysis, identification of source of data, collection and finally carrying out data analysis and interpretation of the results obtained. The final result of the course is preparation of good quality dissertation and also a working paper which may be submitted for publication.

CODE OF CONDUCT

8. Damage to college property/reputation in any form is punishable. If found guilty, responsible individual(s) would be liable to pay for the damages in addition to repercussion faced.

10. Students shall require prior permission from the principal for organizing/ involvement in any activity (monetary/non-monetary in nature) in the college premises.
11. Consumption and possession of tobacco or alcohol or any form of intoxicant in the college campus is prohibited and punishable.
12. A student applying for medical Leave must produce a medical certificate from a registered medical practitioner within seven days of resuming classes.
13. Accompanying of unauthorized personnel in college campus is prohibited and punishable.
14. Students are expected to clear/pay their dues (sports, library, other damages etc.) before collecting their results. On failing to do so, the college reserves the right to withhold the Examination result.
15. Students should not involve in unethical practices such as **smoking, drinking alcohol, consumption of drugs, other unethical practices** and shall adhere to dress code.
16. Parents/Guardians are advised to contact the College authorities from time to time in order to apprise themselves of the progress of their wards and their attendance.
17. Use of unfair means during examination (ISA/SEE) is strictly prohibited. A student, if found guilty, shall be liable for punishment as per the rules prescribed by Goa University.
18. Unauthorized use of mobile phones in class is strictly prohibited. Any student violating this rule shall face disciplinary action.
19. Security personnel or any staff appointed by the principal will have full authority to check and verify the identity cards of every student and have right to interrogate any student, in view of security concerns of the college.

Maintenance of college discipline, adherence to its rules and code of conduct and obedience to the instruction issued from time to time by the principal or other college authorities will be mandatory and binding on each student. Appropriate disciplinary action will be taken which includes suspension/expulsion and rustication as per the directives of Goa University and College Discipline Committee.

Objectives, Roles and Responsibilities of College Internal Complaints Committee

1. Prevent discrimination and sexual harassment, by promoting gender amity among students and employees;
2. Deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment; The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 came into being after it was passed in the Parliament of India.

It should be noted that according to the Supreme Court guideline Sexual harassment can be defined as “unwelcome” sexually determined behaviour (whether directly or by implication) as:

1. Physical contact and advances;
2. Demand or request for sexual favours;
3. Sexually coloured remarks;
4. Showing pornography; and
5. Other unwelcome physical, verbal or non-verbal conduct of a sexual nature. (Vishaka judgment by Supreme Court)

- **The following is also sexual harassment and is covered by the Committee:**

- Eve-teasing
- Unsavory remarks,
- Jokes causing or likely to cause awkwardness or embarrassment,
- Innuendos and taunts,
- Gender based insults or sexist remarks,
- Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like,
- Touching or brushing against any part of the body and the like,
- Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings,
- Forcible physical touch or molestation and
- Physical confinement against one’s will and any other act likely to violate one’s privacy.

The Committee shall meet as often as may be needed and appropriate.

Students are motivated to take part in various extra-curricular activities.

1. Department of Physical Education and Sports

The Department of Physical Education and Sports of M.E.S Vasant Joshi College aims at all round development of each and every student through the participation in various games and sports. The Department organizes various activities and intra-murals such as Inter-class Tournaments, Athletic Meet, which provides an opportunity to the students to showcase their talents. 2. National Service Scheme (NSS)

National Service Scheme (NSS) is a voluntary community service scheme for the youth studying in the higher educational institutions. The aim of NSS is to bring out a positive social and political change in the lives of youth by developing various dimensions of their personality. NSS volunteers are made socially, emotionally, politically and environmentally sensitive towards the process of nation building. The NSS Unit organizes a 7 day residential 'Annual Special Camp' in a rural area.

All students are encouraged to enrol for NSS. A student joining NSS shall complete 240 hours of NSS regular activity over a period of four semesters completing 60 hours of regular N.S.S activity per semester and one 7 day residential 'NSS Annual Special Camp'.



On successful completion of the above activities, the NSS volunteer shall become eligible to receive a 240 hours completion certificate, issued by Directorate of sports and Youth Affairs, Campal, Panaji, Goa. The NSS Volunteers who complete 60 hours of NSS activity, participation in Annual Special camp, National and international Camps are awarded entitlement marks.

3. National Cadet Corps (NCC)

There are 3 divisions/ wings of NCC in M.E.S. Vasant Joshi College viz, **Army Boys Wing, Army Girls Wing and Naval Wing**. Army Boys Wing and Naval Wing are available for boys (SD) and girls (SW). NCC is open to all regular students of the college on a voluntary basis. Total training period is three years. The cadets have to appear for 'B' certificate exam after completion of two years and 'C' certificate exams after three years of training. NCC provides a suitable environment to motivate the youth to take up a career in the armed forces. Free SSB guidance is provided to interested cadets. NCC provides uniform, washing allowance, refreshments during the parade, T.A., D.A. for attending camp, free messing and boarding during camps.

Special weightage and reservation are granted to all NCC 'B' and 'C' certificate passed cadets in armed forces, central paramilitary forces and all the state police forces



4. Activities organized by Various Associations/Cells and Departmental Associations /Clubs

The College Council, various associations and cells such as the Debating Association, Association of Art and Culture, Literary Association, Women's Cell and Departmental Associations organize co-curricular and extra-curricular activities for the benefit of students.

FACILITIES

The College offers the following facilities on the campus:

Library: The College Library is automated using KOHA Software. The Library has a total collection 44055 of Books, 54 Periodicals (Magazines/Journals). Library Subscribes to 16 Local and National Newspapers.

The Library is a Member of UGC INFLIBNET NLIST Programme which gives access to E-books and e-Journals. The college Library has registered for the National Digital Library. The Library Facilities are also extended to the public. The Library has Book Bank Facility wherein set of Textbooks are given to needy and meritorious students. Students are given two library cards to borrow books for a period of 08 days. Rules and Regulations of the Library are displayed on the Library Notice Board.

Laboratories: The college has well-equipped laboratories, namely, IT Lab, Psychology Lab and Economics Lab.



Sports: The sports facilities include gymnasium, gymkhana/ multi-purpose hall for indoor games, football ground, volleyball court and two basketball courts.



Stationery Shop: The college has a stationery shop which also provides photocopying and printing facilities.

Cafeteria: We now have our very own open-air cafeteria on campus 'MESCAFE' which provides a student friendly ambience.

Canteen: The College has a spacious canteen offering snacks and lunch.

Counselling: The services of two full-time counselors are available for the benefit of students in areas of counselling such as career guidance, family issue, peer pressure, addiction etc. The counselors are available on all days of the week from 8.00 a.m. to 2.30 p.m.


