CASE STUDY ON BEIRUT BLAST:

At least 100 people were killed and nearly 4,000 injured in a massive explosion at Lebanon's capital Beirut. The explosion, according to the Lebanon government, was of over 2700 tonnes of ammonium nitrate stored for six years in a warehouse in the port. Multiple reports suggest that a huge tremor-causing explosion was preceded by a fire, possibly of firecrackers. The vibrations of the blast, which were initially misconstrued by some, as detonation of some nuclear device, were even felt around 240 km away in Cyprus.

What is known about the blast till now?

A giant explosion at a warehouse took place around 6 pm local time at Beirut port. The videos of the blast, show a fire next to a building followed by a huge explosion. Based on the visuals and sounds during the initial fire, experts have said that it could possibly be of firecrackers. Within hours, reports came up quoting Lebanon government officials that the explosion was that of over 2,750 tonnes of ammonium nitrate, seized six years ago.

While it is not clear as to the exact sequence of events leading to the explosion, various theories of it being an attack or an act of sabotage are being verified as part of the investigation.

Large quantities of stored ammonium nitrate are regarded as a major fire hazard, with multiple reported cases across the world. Big stockpiles of ammonium nitrate can explode in two possible ways. One is by some type of detonation or initiation because the storage came in contact with explosive mixture or an outside source of energy. Second, the blast can result due to a fire which starts into the ammonium nitrate storage because of the heat generated due to the oxidation process at large scale. There are several documented examples of deadly ammonium nitrate fire

and explosion incidents in the past, some with large numbers of fatalities like in China in 2015 and in Texas in 1947.

4. You being a Dangerous goods safety advisor and specialist in handling and storage of Ammonium nitrate, has been appointed as a chief investigator in the blast. How will you go about collecting evidence in the blast?
5. From the evidence collected by you, what is the main cause of the blast? Is it different from the cause you gave in answer to question no. 1?
6. Give your expert opinion on the role of Port authority in the blast.
