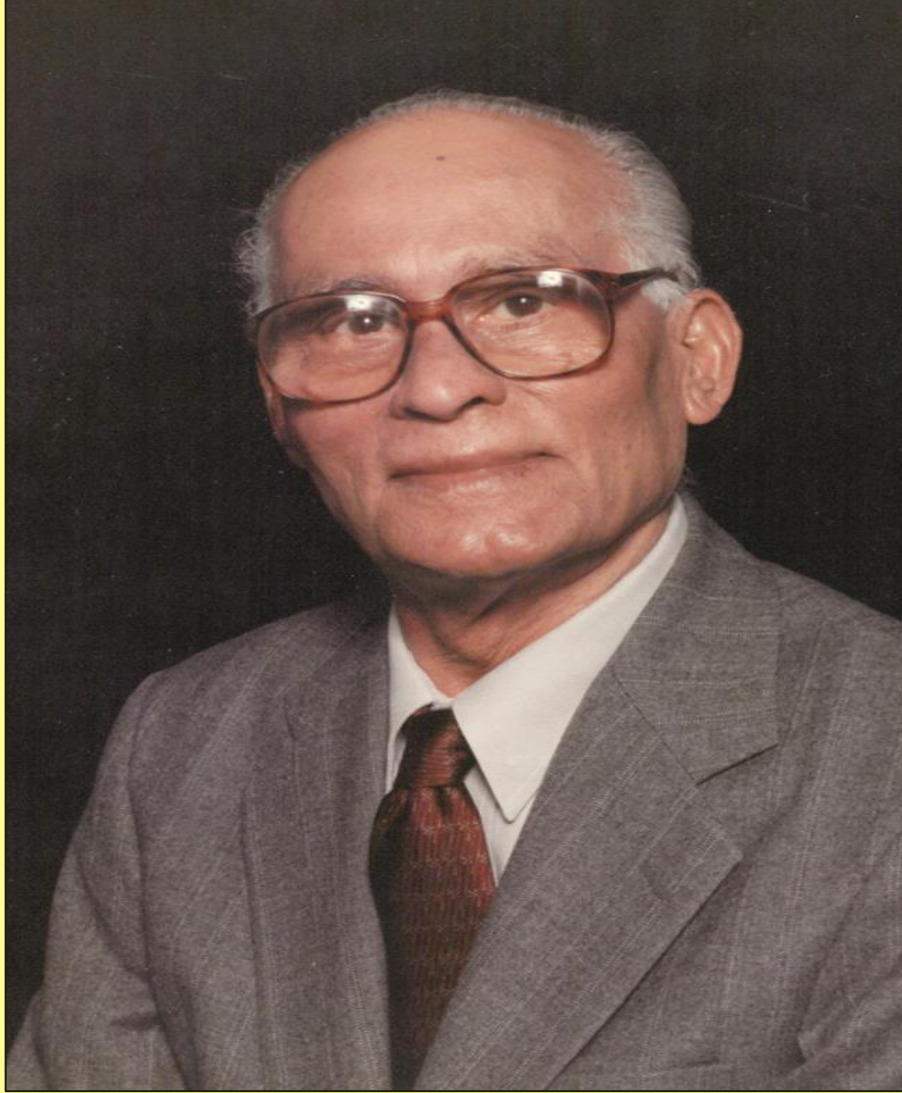

Murgaon Education Society's Vasant Joshi College of Arts & Commerce is one of the premier institutions of higher education in the state of Goa. The college was founded by the great visionary and philanthropist Late Shri. Vasantrao Subrai Joshi to cater to the need of educational upliftment of youth in Vasco- da- Gama in particular and the state of Goa in general. The College premises was shifted to the present campus in 1985. Over the years, the campus has been transformed from barren, rocky and unyielding land into a lush green, fertile paradise where students aspire to pursue their higher studies.

It was one of the first composite Arts and Commerce colleges in the state of Goa to be affiliated to the University of Mumbai and then to Goa University. The college is currently offering five undergraduate programmes in Arts, Commerce, B.C.A., B.B.A. (General), B.B.A. (Shipping and Logistics) and one postgraduate programme, namely M.Com. To cater to the requirements of the Shipping and Logistics industry, M.E.S. Vasant Joshi College introduced B.Com. (Shipping Management) which was initially funded by UGC for five years and is currently running as a self-financed programme as Bachelor of Business Administration (Shipping & Logistics).



The B.B.A. (Shipping and Logistics) programme is the first undergraduate programme in India which addresses the commercial and managerial side of the shipping industry. At present, the college has approximately 1601 students and 69 full-time teaching faculty.



The college encourages high academic standards. We instil in our students a passion for learning and acquiring knowledge that they will require to make a positive contribution to the society. The college imparts learner-centric education which aims at the holistic development of the students by developing creative and critical thinking, nurturing innovations and excellence, developing professional skills etc.

Two Years Full Time Self-Financed Programme Affiliated to Goa University

The **M.Com programme** offered by the college is a two-year full time degree programme affiliated to Goa University. At present the M.Com programme offers specialisation in Accounting and Finance only. The M.Com programme is based on the existing course structure for the same programme offered by Goa Business School of Goa University.

ADMISSION

I) PROCEDURE:*

(A) For M. Com. Semester I & II

1. Challan to be collected from college administrative section (Accountant), payment to be made, scan copy of payment made to be attached to challan, fill Google form submit online and print to be submitted to accountant.
2. The application form shall be filled online at www.mescollege.org
3. Students should have a Gmail account.
4. A passport size photo (not exceeding 1 MB) should be uploaded.
5. The admission form shall be uploaded along with the following documents (each document not exceeding 1 MB):
 - a) Scanned copy of original mark sheet of B.Com examination and two self-attested photocopies of the same.
 - b) Eligibility Certificate (in original) issued by Goa University (for those students who have passed B.Com examination through any other recognized University other than Goa University if applicable)
 - c) Scanned copy of original Aadhar card and first page of the bank pass book
 - d) Scanned copy of original caste certificate
 - e) Undertaking by the student
 - f) Undertaking by the parent
 - g) Undertaking for discipline attendance
6. Identity Card Slip
7. Six copies of recent passport size photographs
8. Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
9. The student will receive an email on successful payment of fees confirming his/her admission.

B) For M. Com. Semester III & IV

- 1) Challan to be collected from college administrative section (Accountant), payment to be made, scan copy of payment made to be attached to challan, fill Google form submit online and print to be submitted to accountant.
- 2) The application form shall be filled online at www.mescollege.org
- 3) Students should have a Gmail account.
- 4) A passport size photo (not exceeding 1 MB) should be uploaded.
- 5) The admission form shall be uploaded along with the following documents (each document not exceeding 1 MB):
 - a) Scanned copy of original mark sheet of previous semester examination (I and II)

- b) Scanned copy of original Aadhar card and first page of the bank pass book
 - c) Scanned copy of original caste certificate
 - d) Undertaking by the student
 - e) Undertaking by the parent
 - f) Undertaking for discipline and attendance
 - g) Students from other colleges (not affiliated to Goa University) should submit provisional Eligibility Certificate issued by Goa University and Migration Certificate and Transfer Certificate from their respective Universities.
- 6) Once the admission form is filled and the relevant documents are uploaded, the student will be taken to the online payment gateway for payment of fees.
- 7) The student will receive an email on successful payment of fees confirming his/her admission.

II) Eligibility for Admission [OA-20.6.7 Goa Business School (c) of GU Ordinance]

2.1 The eligibility criteria for admission to the M.Com Programme are as under:

1. Candidates must pass the Bachelor of Commerce Degree examination of Goa University or any other recognized university with a minimum of 45% marks.
2. Candidates must pass the Entrance Examination conducted by Goa University.
3. Admission is based on the Common Entrance Examination conducted by Goa University
4. A candidate admitted for Semester-I shall be deemed eligible for admission for Semester II.

The intake for the M.Com offered by the college is 38 seats.

SEMESTER - I

COM- 500 Advanced Financial Management

This course is designed to provide fundamental knowledge about the company's finances and management. It enable the students to understand the financial decision-making process to enhance shareholders' wealth, and understand the techniques of financial management and apply the methods in financial decision-making.

COM- 501 Capital Markets and Stock Exchange Operations

The objective of the course is to enable students to develop a comprehensive knowledge of the Indian stock markets and their operations.

COM- 502 Entrepreneurship and Venture Capital

This paper provides students with a basic information w.r.t (1) To identify the origin, development, and growth of entrepreneurship, what makes India different, the role and importance of creativity, growth agents, and the vicious circle of poverty, and (2) To analyze the evolution of venture capital financing over the years, identify various legal structure of venture capital firms, and basics about the regulatory environment, (3) To evaluate potential business ideas, preparing a successful business plan, and various methods used for business valuation, and (4) To assess different stages of life cycles and how venture capitalists carry out financing, venture capital scenario including the exit strategy.

COM- 503 Organizational Behaviour

The course teaches students about individual and group behavior in an organization. It also provides ways to deal with the different levels of conflict and manage it. In this competitive world where there is a big race among individuals, understanding oneself and others can help to gain an advantage. Human behavior is unpredictable, so understanding of causes and effects of the behavior is an essential area for individual who interacts in the community and society

COM-521 Advanced Corporate Accounting

This course is designed (1) To gain knowledge in theory as well as practice in corporate accounting. (2) To enable students to prepare companies' financial statements within the framework of the Company Act, 2013. (3) To enable students to prepare financial statements of Banking and Insurance companies. (4) To help students understand the techniques of restructuring and liquidating corporate entities.

COM- 522 Financial Services Operations

The student will be equipped with basic knowledge of Financial Services. The student will learn the process and methodology of Credit rating Agencies with services provided. Students will understand the working mechanism of Securitization with Legal Aspects and Depositories Operations.

SEMESTER - II

COM- 504 Marketing and Consumer Behaviour

This course is designed (1) To understand the significance of marketing and the latest developments in marketing. (2) Assess how segmentation, targeting, and positioning are done and the marketing mix. (3) To identify the ways of influencing consumer behavior. (4) To measure consumer behavior regarding technology adoption, level of satisfaction, and content co-creation.

COM- 505 Management of Mutual Funds

This course focuses on (1) Mutual funds Organization structure and role of different parties. (2) Assess offer documents of different schemes and SEBI requirements in preparation of Offer documents. (3) assess the suitability of Scheme Information Document (SID), Statement of Additional Information (SAI), and Key Information Memorandum (KIM) (4) prepare

Investment plans, products and services offered to present and prospective investors in the financial market (5) assess different types of plans; Systematic Investment Plan (SIP); Systematic Transfer Plan (STP), and Systematic Withdrawal Plan (SWP).

COM- 506 Security Analysis & Portfolio Management

The main objectives of the course are (1) To enable students to understand the analysis of Return and Risk of Securities. (2) To enable students to analyze the Equity and Debt of companies. (3) To enable students to study and select a Portfolio. (4) To enable students to evaluate Portfolio

performance and revise the portfolios.

COM- 507 Financial Derivatives

The objective of the course are (1) To understand the derivative markets and the trading mechanism in India. (2) To learn the risk management techniques in derivative markets. (3) To understand the possibility of exploring the arbitrage possibilities with the integration of stock and derivatives markets. (4) To learn the logical and analytical skills to understand the applications of risk management techniques in the field of derivatives markets.

COM- 525 Direct Taxes

This course aims at providing the students with a comprehensive introduction to Income Tax to enable them to compute income from different sources and calculate tax liability for individuals and corporate.

COM-526 Cost and Management Accounting

This Course aims (1) To understand the nature, scope, and utility of Cost and Management Accounting. (2) To understand how Cost Accounting arises from the need to make business decisions. (3) To acquire knowledge and understanding of the concepts, techniques, and practices of Cost and Management Accounting and to develop decision-making skills

SEMESTER - III

COM- 600 Research Methodology

This course is designed (1) To understand the significance of the research, carry out the literature review, prepare content analysis, and identify the research gap. (2) To develop research questions, objectives, and related hypotheses. (3) To learn how to process the data and interpret results.

COM- 601 Basic Econometrics

Basic econometrics course is designed (1) To acquire foundational knowledge of regression analysis and develop skills in applying regression models to data. (2) To understand basic knowledge and skills of diagnostic testing concerning regression models. (3) To enable learners to master basic econometric techniques for analysis of cross-section data. (4) To enable learners to acquire basic time series analysis and forecasting skills using econometric and event study methodology.

COM-602 Qualitative Research

The course aims at (1) Identifying the role and importance of various research approaches (quantitative, qualitative, and mixed). (2) To understand the process of carrying out qualitative research and identify relevant areas, develop research questions and related interview questions. (3) To enable and acquire the ability to active listening skills in interviews and focus group discussions on engaging in data collection, by expressing interest in collecting the information, so participants get encouraged to provide relevant and in-depth information promptly. (4) To engage in preliminary interviews in classrooms, improvise the skill by listening, reviewing, and understanding the recorded interviews, and conducting mock interviews and role-plays to have more clarity before going for the final interview. (5) To conduct various ways of analyzing the qualitative data collected to provide appropriate and relevant interpretations. (6) To prepare and submit a qualitative research report.

COM- 621 Corporate Valuation

The main objectives of the course (1) To enable students to apply the various approaches to Corporate Valuation. (2) To enable students to apply the Enterprise Discounted Cash Flow valuation techniques in companies. (3) To enable students to apply the Relative Valuation & Non-DCF- Approaches to Valuation in companies. (4) To enable students to apply Value Enhancement techniques in companies.

COM- 622 Corporate Mergers and Acquisitions

This course designed (1) To understand the Mergers and Acquisitions, Various Forms of Corporate Restructuring, and Corporate Restructuring in Recent times in India (2) Understand Theories of Mergers, Types of Mergers & Mergers, and Acquisitions Process (3) To acquire knowledge and understanding of Takeover defenses.

COM- 623 Indirect Taxes

This course aims to gain expert knowledge of Goods and Service Tax and Customs Duty principles, its relevant laws, and provisions..

COM-624 Financial Risk Management

The course enable the students to learn about the various types of risks faced by businesses, learn techniques of managing the risks, and apply these techniques in different scenarios.

COM-625 Treasury and Forex Management

The Course aims (1) To understand and assess the objectives of Treasury Management (2)To learn and understand the function and scope of Treasury Management

COM- 626 Cost Management and Control

The main objectives of the course are: (1) To understand the basis of cost management and how cost control is carried out. (2) To have an in-depth knowledge of various cost management techniques used to control costs. (3) To understand the practical applications of linear Programming, network analysis, transportation problems, and assignment problems

SEMESTER - IV

COM- 603 Advanced Econometrics

Advanced econometrics develops (1) To enable learners to apply cross-section regression models on limited dependent variables. (2) To enable learners to acquire time series modeling and forecasting skills with advanced analytical techniques for short-term and long-term relationships in variables of interest. (3) To enhance skills in estimation and forecasting of volatility. (4) To provide skills in building panel data models for examining dependency relationships amongst financial variables.

COM-604 Business Analytics

The Course objectives are (1) To apprise the learners about the Business analytics process and provide exposure to relevant applications and Programmemeing used in Business analytics. (2) To develop expertise in learners in using data visualization tools and techniques for obtaining business insights. (3) To train learners in Python. (4) To enable learners to apply machine learning techniques.

COM-604 Data Insights and Analytics

This course aims at (1) To enable the learners to identify data types used in analytics. (2) To enhance the learners' skills in applying relevant statistical and analytical tools for primary and secondary data. (3) To thoroughly train learners using various data analytical software such as R, Tableau and Spread Sheet. (4) To enable learners to Create interactive visualization for better insight using various visualization tools. (5) To enable the learners to apply data analytics in practical research and business.

COM- 651 Dissertation

This course helps the students (1) To identify the research gap using extensive literature review and preparation of content analysis. (2) To identify the source of data, ways of collecting the data and applying relevant tools and techniques for analysing the data collected. (3) To develop a standard quality research report clearly showing all the relevant components of an effective report and preparing a working paper.

CODE OF CONDUCT

10. Students shall require prior permission from the principal for organizing/ involvement in any activity (monetary/non-monetary in nature) in the college premises.
11. Consumption and possession of tobacco or alcohol or any form of intoxicant in the college campus is prohibited and punishable.
12. A student applying for medical Leave must produce a medical certificate from a registered medical practitioner within seven days of resuming classes.
13. Accompanying of unauthorized personnel in college campus is prohibited and punishable.
14. Students are expected to clear/pay their dues (sports, library, other damages etc.) before collecting their results. On failing to do so, the college reserves the right to withhold the Examination result.
15. Students should not involve in unethical practices such as **smoking, drinking alcohol, consumption of drugs, other unethical practices** and shall adhere to dress code.

16. Parents/Guardians are advised to contact the College authorities from time to time in order to apprise themselves of the progress of their wards and their attendance.
17. Use of unfair means during examination (ISA/SEE) is strictly prohibited. A student, if found guilty, shall be liable for punishment as per the rules prescribed by Goa University.

Objectives, Roles and Responsibilities of College Internal Complaints Committee

3. Sexually coloured remarks;
4. Showing pornography; and

5. Other unwelcome physical, verbal or non-verbal conduct of a sexual nature. (Vishaka judgment by Supreme Court)

• **The following is also sexual harassment and is covered by the Committee:**

- Eve-teasing
- Unsavory remarks,
- Jokes causing or likely to cause awkwardness or embarrassment,
- Innuendos and taunts,
- Gender based insults or sexist remarks,
- Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and the like,
- Touching or brushing against any part of the body and the like,
- Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets or sayings,
- Forcible physical touch or molestation and
- Physical confinement against one's will and any other act likely to violate one's privacy.

The Committee shall meet as often as may be needed and appropriate.

Students are motivated to take part in various extra-curricular activities.

1. Department of Physical Education and Sports

The Department of Physical Education and Sports of M.E.S Vasant Joshi College aims at all round development of each and every student through the participation in various games and sports. The Department organizes various activities and intra-murals such as Inter-class Tournaments, Athletic Meet, which provides an opportunity to the students to showcase their talents. The College also participates in other extra-murals and competitive games held by the Goa University and other associations and Institutions.



The College Director of Physical Education & Sports, Dr. Savio Fernandes and Instructor in Physical Education, Shri. Gauresh Kamat provides scientific fitness training and coaching to the students representing the college at various competitions. The individuals are not only trained for performance and medals but they are also credited with values and discipline. The College has also developed

a Sports Policy and the sports department ensures that the Sports Policy is being implemented in the college. Other benefits such as Sports Merit Marks, Duty Leave, Practice Allowance, Travelling Allowance and Kit Allowance as per the guidelines of the University are provided to the students. Due recognition is also given to the students who achieve glory in sports by forwarding the reports to the local newspaper

2. National Service Scheme (NSS)

National Service Scheme (NSS) is a voluntary community service scheme for the youth studying in the higher educational institutions. The aim of NSS is to bring out a positive social and political change in the lives of youth by developing various dimensions of their personality. NSS volunteers are made socially, emotionally, politically and environmentally sensitive towards the process of nation building. The NSS Unit organizes a 7 day residential 'Annual Special Camp' in a rural area.

All students are encouraged to enrol for NSS. A student joining NSS shall complete 240 hours of NSS regular activity over a period of four semesters completing 60 hours of regular N.S.S activity per semester and one 7 days residential 'NSS Annual Special Camp'.



On successful completion of the above activities, the NSS volunteer shall become eligible to receive a 240 hours completion certificate, issued by Directorate of sports and Youth Affairs, Campal, Panaji, Goa. The NSS Volunteers who complete 60 hours of NSS activity, participation in Annual Special camp, National and international Camps are awarded entitlement marks.

3. National Cadet Corps (NCC)

There are 3 divisions/ wings of NCC in M.E.S. Vasant Joshi College viz, **Army Boys Wing, Army Girls Wing and Naval Wing**. Army Boys Wing and Naval Wing are available for boys (SD) and girls (SW). NCC is open to all regular students of the college on a voluntary basis. Total training period is three years. The cadets have to appear for 'B' certificate exam after completion of two years and 'C' certificate exams after three years of training. NCC provides a suitable environment to motivate the youth to take up a career in the armed forces. Free SSB guidance is provided to interested cadets. NCC provides uniform, washing allowance, refreshments during the parade, T.A., D.A. for attending camp, free messing and boarding during camps.



Special weightage and reservation are granted to all NCC 'B' and 'C' certificate passed cadets in armed forces, central paramilitary forces and all the state police forces

4. Activities organized by Various Associations/Cells and Departmental Associations /Clubs

The College Council, various associations and cells such as the Debating Association, Association of Art and Culture, Literary Association, Women's Cell and Departmental Associations organize co-curricular and extra-curricular activities for the benefit of students.

FACILITIES

The College offers the following facilities on the campus:

Library: The College Library is automated using KOHA Software. The Library has a total collection 44055 of Books, 54 Periodicals (Magazines/Journals). Library Subscribes to 16 Local and National Newspapers.

The Library is a Member of UGC INFLIBNET NLIST Programme which gives access to E-books and e-Journals. The college Library has registered for the National Digital Library. The Library Facilities are also extended to the public. The Library has Book Bank Facility wherein set of Textbooks are given to needy and meritorious students. Students are given two library cards to borrow books for a period of 08 days. Rules and Regulations of the Library are displayed on the Library Notice Board.

Laboratories: The college has well-equipped laboratories, namely, IT Lab, Psychology Lab and Economics Lab.



Sports: The sports facilities include gymnasium, gymkhana/ multi-purpose hall for indoor games, football ground, volleyball court and two basketball courts.



Stationery Shop: The college has a stationery shop which also provides photocopying and printing facilities.

Cafeteria: We now have our very own open-air cafeteria on campus 'MESCAFE' which provides a student friendly ambience.

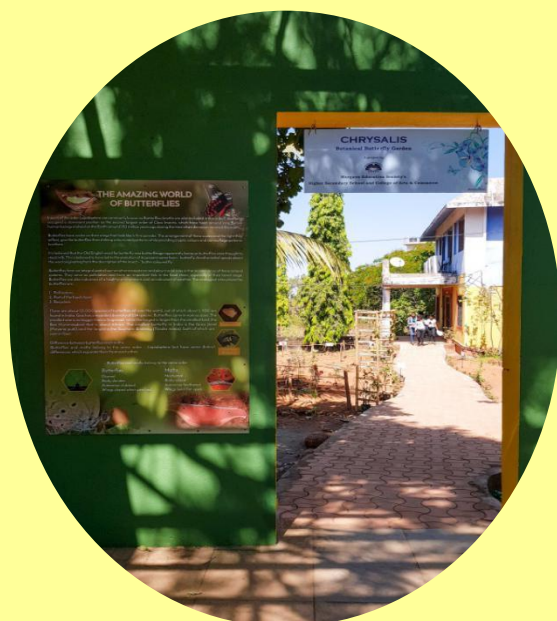
Canteen: The College has a spacious canteen offering snacks and lunch.
