Shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.
- 5. all other terms and duties as per UGC notification

The tenure of this Squad shall be two years from the date of issue of this Notice.
